## UNIVERSITY OF CALIFORNIA TUITION AND/OR FEE REMISSION POLICIES FOR GRADUATE STUDENT ACADEMIC APPOINTEES 2006-07

Students who have established California residency pay in-state fees, but not out-of-state tuition.

Registered graduate student teaching assistants, readers and tutors with appointments of at least 25% time receive a 100% remission of in-state educational and registration fees.

+++++

For Graduate Student Researcher titles, all campuses have established fee and/or tuition remission policies, contingent upon the student holding a minimum percent time appointment. Campuses provide remission of in-state educational and registration fees (Berkeley, Davis, Irvine, San Diego, Santa Barbara and Santa Cruz also cover campus fees; Los Angeles and Riverside do not cover campus fees.) These policies and minimum appointment levels are as follows:

Berkeley -- (As of 7/95) With a 45% time or greater appointment as Graduate Student Researcher for a full semester, full tuition and fees are paid on behalf of the student. (As of 7/01) GSRs with appointments between 25% and 45% time receive 100% remission of educational plus registration fees, but no tuition remission.

Davis -- (As of 10/04) With a 25% time or greater appointment as Graduate Student Researcher for a full academic term, full tuition and fees are paid on behalf of the student.

*Irvine* -- (As of 10/90) With a 25% time or greater appointment as Graduate Student Researcher for a full academic term, full tuition and fees are paid on behalf of the student.

Los Angeles -- (As of 7/00) With a 45% time or greater appointment as Graduate Student Researcher for a full semester, full tuition and fees (except campus fees) are paid on behalf of the student. (As of 7/01) GSRs with appointments between 25% and 45% time receive 100% remission of educational plus registration fees, but no tuition remission.

Riverside -- (As of 10/93) With a 45% time or greater appointment as Graduate Student Researcher for a full academic term, full tuition is paid on behalf of the student. (As of 7/01) GSRs with appointments at greater than 25% time receive 100% remission of educational plus registration fees, but not campus fees. GSRs with appointments between 25% and 45% time receive no tuition remission.

San Diego -- (As of 7/85) With a 25% time or greater appointment as Graduate Student Researcher for a full academic term, full tuition and fees for that term are paid on behalf of the student.

San Francisco -- (As of 7/93) With a 25% time or greater appointment as Graduate Student Researcher for a full academic term, full fees (but no out-of-state tuition) are paid on behalf of the student.

Santa Barbara -- (As of 7/96) With a 35% time or greater appointment as Graduate Student Researcher for a full academic term, full tuition and fees are paid on behalf of the student. (As of 7/01) GSRs with appointments between 25% and 35% time receive 100% remission of educational plus registration fees, but no tuition remission.

Santa Cruz -- (As of 9/96) With a 25% time or greater appointment as Graduate Student Researcher for a full academic term, full fees and tuition for that term are paid on behalf of the student.

Some campuses require students under these programs to be pursuing a doctoral or certain professional degrees, to hold a certain GPA, to have completed a certain number of terms, and/or to be within departmentally established normative-time-to degree periods.

All UC campuses have available a variety of full or partial nonresident tuition fellowships based on merit and need. Graduate students (except international students) can qualify for legal residence by their 2nd year of graduate school, reducing their educational costs (eliminating tuition and leaving only fees to pay).

All registered graduate student academic appointees also receive full student health insurance program premium remission as long as they are appointed for the full term at 25% time or greater.
