## Subject: New daily maximum limit of business meals for UCOP-only meetings

Colleagues.

According to a State Auditor recommendation, the Office of the President was asked to reevaluate reimbursement rates for business meals for UCOP staff-only meetings. An analysis was completed by the Event Services Group and Business Resource Center which indicates that the volume of UCOP staff-only meals is low and it is rare for a meeting to include several meals within a day.

Based on this review, a lower daily business meal maximum is reasonable. Therefore, effective immediately, the maximum per person expenditures for UCOP staff-only meeting meals will be reduced from the current maximum to a new maximum of \$74 per day.

In addition, meetings must be at least three hours in duration and include the normal meal period for breakfast, lunch, and/or dinner and must also meet the three hour minimum for light refreshments. For further details, please see the attached Frequently Asked Questions (FAQ) document.

These rates should be achievable for any meetings held at a UCOP facility or nearby conference center (CSU East Bay, OCC, etc.) where an outside caterer can be hired. Any UCOP staff-only meeting above these new rates must receive exceptional preapproval as outlined <a href="https://example.com/here">here</a>. Any exceptions also require pre-approval before financial commitments are made with vendors. Please note, meetings that include outside or campus participants cannot exceed the maximum per person rates and reasonableness guidelines as outlined in Appendix A of UC Policy BUS-79.
