### **RICHARD DEBUS**


Professor of Biochemistry Department of Biochemistry UC Riverside Southern California Cohort

a postdoctoral fellow in the MSU-DOE Plant Research Laboratory at Michigan State University from 1985-1988. He joined the Department of Biochemistry at UC Riverside in 1988. His research combines the tools of biophysical chemistry and molecular biology to elucidate the mechanism of water-oxidation/O2 formation by the catalytic Mn4Ca cluster in Photosystem II. He is also a Cooperating Faculty Member in the Department of Chemistry and teaches classes in both physical chemistry and biochemistry. He has served in departmental leadership positions almost continuously since 1998, including many years as Graduate Advisor for the Biochemistry and Molecular Biology Graduate Program and many years as Chief Undergraduate Advisor for the Biochemistry in 2007 and from 2010 to 2017. He is a Fellow of the American Association for the Advancement of Science.

### **XIAOPING HU**


Professor and Chair Department of Bioengineering UC Riverside Southern California Cohort
