

**Intercampus Summer Enrollment System (ISE)
Home Campus Output File**

Overview

Population

The ISE Home Campus Output file contains one student record and one or more course records for each UC student for each host campus at which the student has summer enrollment activity.

Record Types

Header Record (Record Type Code-Student = A)

The first record on the file must be a Header Record.

Student Record (Record Type Code-Student = B)

Each Student Record contains information identifying a UC student enrolled at a host campus.

Course Record (Record Type Code-Student = C)

Each Course Record contains information identifying a UC student and the course(s) in which the student is or was enrolled at the host campus. Historical course records, providing information about prior enrollment statuses are included.

Trailer Record (Record Type Code-Student = D)

The last record on the file should be a trailer record providing counts of student records and course records.

Schedule

UCOP will create this file on a weekly basis from January 1 through February 29, on a daily basis from March 1 through September 30, and again on a weekly basis from October 1 through December 31 each year. The file will reflect summer enrollment data for the summer period in the calendar year during which the file is submitted.
