## **Committee Charge:**

### General Charge

For 2009/2010, the Committee is charged with fulfilling its standing charge, Article VIII. Section 1.e.2 (approved by UCOP March 23, 2009):

- a. Solicit and review research proposals submitted to the Universitywide Research Grants for Librarians Program by LAUC members and recommend funding of proposals to the Office of the President.
- b. Develop, monitor, and revise, as needed, procedures for carrying out the review of research proposals.
- c. Develop guidelines for application to the Universitywide Research Grants for Librarians Program and recommend revisions as needed.
- d. Advise the President and the Executive Board on issues related to research and professional development for librarians and address other subjects at the request of the President.

### Specific Charges for 2009-2010

Last year, after the first Call for research grant applications, the Committee received approval to create and offer LAUC Mini Grants and Presentation Grants in addition to the Research Grants. We sent out additional Calls and adjusted R&PD calendars to incorporate the additional new grants and timelines. The Committee needs to monitor its experience with the two new types of grants in this the first full year of their implementation and appropriately revise the Call, guidelines and timetables for all three types of grants – the Research Grant, the Mini Grant, and the Presentation Grant.

### **Summary of Action Items:**

1. Contact 2007/2008 Research Grant Award Recipients to determine the current status of their Research Projects and solicit a final report or final project as required in Section IV. J. and Section VI of the Guidelines respectively.
2. Contact 2008/2009 Research Grant Award Recipients to determine the current status of their Research or Mini Grants and to solicit an annual report, final report or final project as required in Section IV. J. and Section VI of the LAUC Research Guidelines respectively.
3. Monitor the affect the two new types of grants will have during the entire grant cycle.
4. Determine what if any timing issues might still exist for funding potential presentation grants awards for recipients planning on delivering their presentations in May or June of 2010 prior to the release of funding on July 1, 2010.
5. Revise the Call, calendar, guidelines, supporting documents and forms, and any other relevant document as needed to accurately reflect the current policies, processes and practices.

To date the LAUC R&PD Committee has accomplished the following:

- Revised the Call & Calendar and Guidelines to a) incorporate Mini-Grants and Presentation Grants, b) make the Guidelines more accessible to applicants, and c) post the revisions to the Committee website with the assistance of the LAUC Web Manager.

- Updated the Table of Past Recipients to include 2008/2009 Grant Award Recipients with the assistance of the Web Manager.
- Distributed the 2009/2010 Call and Calendar to the membership on October 26, 2009.
- Established a confidential Committee website and listserv on bSpace.
- Established a ReadyTalk account for future committee meetings with funding support by the UCR Libraries Administration.
