DESCRIPTION OF REQUEST:

Prior to Release 1642, the display sequence was in check date descending order and in PRI_GROSS_CTL ascending order.

After Release 1642, the system sorts the rows in IBRS by check date in descending order and then the new PAR_SEQ_NO field in ascending order. This modification results in that the latest PAR is not in the top row.

Modify the IBRS function so that the system displays the most current PAR activity first, then the next most current, and so on, to correspond to changes made to the detail screens announced in Release 1642.
