This release addresses the following Service Request:

Service Request 82790

Service Request 82790 notes that the bargaining unit for the Librarians (LX) has agreed to participate in the Salary Reduction/Furlough plan introduced by releases 1876 and 1877. They will use the same rates as employees who are currently participating, but will have different begin and end dates:

- monthly: 10/01/09 – 09/30/10
- biweekly: 10/04/09 – 10/02/10

This release includes an updated SALRED file, to be used with programs PPO1876B and PPP641.

Table Updates

SALRED (Salary Reduction Percent and Furlough Accrual Factor File)

The SALRED file was originally released as part of R1876, and a copy of the file was also included with R1877. The file included with this release has been updated to **delete** the single-line LXC entry and to **add** a set of percents and factors for LXC with their begin and end dates.

Installation Instructions

1. Replace the current version of the SALRED file with the file provided with this release (PAYDIST.Rrrrr.SALRED); be sure to incorporate any local changes you may have made to your SALRED file.
2. Run PPOT1876B with the updated SALRED file (DD FACTOR) and the following run specification (DD CARDFIL) to create batch EDB update transactions to add SRB and SRS distributions:

| Columns | Content |
|----------------|-----------------|
| 1 - 11 | PPO1876B-SPEC |
| 14 - 15 | Campus location |
| 16 - 18 | Batch number |
| 19 - 21 | Origin |
| 22 - 23 | LX |

Timing of Installation

The timing of this release is **urgent**. The salary reduction distributions must be in place for the computes for the monthly pay period ending 10/31/09 and for the biweekly pay period ending 10/17/09 (if there are any LX unit members paid on a biweekly schedule).

As usual, these updates should be applied to production data only as approved by your campus Payroll Manager.
