  - Provide various maintenance and capital improvements as needed.

### Hillcrest Replacement Hospital

- Fund Sources: State General Fund, State Grant (Children's Hospital Bond Funds)
- Budget: \$84 million (total funded project budget over CFP term). The project includes a component with funding not yet identified.

- Project Objective Categories: Seismic, Aging Plant, Program Improvements, Other Activity Space (Clinical)
- Project would:
  - Construct a replacement hospital for inpatient services.
  - O Built in 1963, the existing Hillcrest Hospital must be retrofitted to seismic requirements set by Senate Bill 1953 or be removed from service by 2030. Because of its aging infrastructure, it would be costly and challenging to seismically retrofit the Hospital to meet modern standards. The Hospital would need to remain operational at its current capacity and level of service during a renovation, requiring expensive and complex phasing; therefore, renovation is not feasible.
  - o This project is a major part of the strategic redevelopment of the Hillcrest Campus.

#### Hillcrest West Wing Decant and Relocation

- Fund Source: Hospital Reserves
- Budget: \$10 million
- 8,500 ASF / 9,000 GSF
- Project Objective Categories: Aging Plant, Seismic
- Project would:
  - Vacate all departments, occupants, equipment, and furnishings to prepare for future demolition of the building.
  - Relocate critical systems into the main hospital at Hillcrest Medical Center and relocate noncritical systems into modular buildings on the Hillcrest Medical Center site.
  - Include renovations at each relocation site; however, this project scope and budget would not include demolition of the West Wing.
