## Professor, Chicana and Chicano Studies Director, Chicano Studies Institute UC Santa Barbara

Dolores Inés Casillas is Professor of Chicana and Chicano Studies and Director of the Chicano Studies Institute (CSI) at the University of California, Santa Barbara. Her research focuses on immigrant engagement with U.S. Spanish-language and bilingual media, the representation of accented Spanish and English languages within popular culture, as well as the integration of Ethnic Studies within K-12

schools. She is the author of Sounds of Belonging: U.S. Spanish-language Radio and Public Advocacy (NYU Press, 2014), which received two book prizes; co-editor, with María Elena Cepeda (Williams College), of the Companion to Latina/o Media Studies (Routledge Press, 2016); and co-editor, with Mary Bucholtz and Jin Sook Lee (UC Santa Barbara), of Feeling It: Language, Race and Affect in Latinx Youth Learning (Routledge Press, 2018). Her current manuscript explores the politics of language learning and language play as heard through different media technologies.

Professor Casillas is part of a collaborative, community-based research project with Professors Mary Bucholtz (Linguistics) and Jin Sook Lee (Education). Together, they co-direct a multi-sited study about language, race and youth, with predominantly Latina/o students. Known as School Kids Investigating Language in Life and Society (SKILLS), students learn how to use the tools of language analysis to carry out original research and community action projects.

She is also co-convener for the Sound Studies Caucus for the American Studies Association (ASA), Director of the Spanish and Bilingual Radio caucus for the Radio Preservation Task Force hosted by the Library of Congress and a regular contributor to Sounding Out!, a sound studies blog. She is also a Board Member of Adelante Charter School, a dual-language (Spanish-English) K-6 elementary school, and the Goleta Education Foundation (GEF), a non-profit that engages the community to invest in local public schools.
