EXECUTIVE SUMMARY

As stated in the Senior Management Group Outside Professional Activities policy (Regents Policy 7707):

Considerable benefit accrues to the University from Senior Management Group (SMG) members' association with external educational and research institutions, not-for-profit professional associations, federal, state and local government offices and private sector organizations. Such associations foster a greater understanding of the University of California and its value as a preeminent provider of education, research, public service, and health care. Such associations also may provide a stimulus for economic development and enhanced economic competitiveness.

While outside professional activities performed by SMG members are often mutually beneficial to the University and the members themselves, and are therefore encouraged, the primary commitment of University of California SMG members must be to the fulfillment of their regular University responsibilities.

Outside Professional Activities can be uncompensated or compensated and can be performed for both non-profit and for profit organizations. Each member of the Senior Management Group submits a list of anticipated activities at the start of each calendar year and throughout the year if new activities are added. At the close of the calendar year, each Senior Management Group member provides a certification noting the hours spent on the activity and any compensation received. Activities reportable as OPA are board memberships (Board of Directors, Board of Trustees, and other Governing Boards/Councils) whether uncompensated or compensated at any amount, and other activities, such as consulting and other advisory roles, with compensation exceeding \$2,500.

OBSERVATIONS

Uncompensated Board Memberships: For Calendar Year 2021, 54 SMG members participated in uncompensated board memberships, compared to 52 SMG members in 2020.

When comparing 2020 and 2021, the number of uncompensated board memberships has decreased (17.7 percent) from 113 to 93, the average hours per activity has increased (7.8 percent) from 19.2 to 20.7 hours per activity, and the average overall hours per SMG member (during and/or outside of business hours) utilized for uncompensated activities has decreased (14.8 percent) from 41.8 to 35.6 hours in calendar year 2021.

Compensated Activities: For Calendar Year 2021, 20 SMG members participated in activities that were board memberships compensated at any amount and/or other activities

that were compensated in excess of \$2,500 in cash or other compensation, compared to 27 in 2020.

When comparing 2020 and 2021, the number of reportable compensated activities decreased (25.0 percent) from 36 to 27, the average hours per activity decreased (8.9 percent) from 42.5 to 37.4, the average hours per SMG member decreased (10.9 percent) from 56.7 to 50.5, the average total compensation per activity decreased (8.8 percent) from \$75.2k to \$68.6k, and the average total compensation per SMG member decreased (7.7 percent) from \$100.3k to \$92.6k.

For compensated activities SMG members are required to utilize vacation time when compensated activities are completed during business hours. A total of 465 hours of vacation was used to offset the time during business hours for the reported activities.

- **Activities Undertaken for Calendar Year 2022:** Anticipated activities at the start of each calendar year are reported for two six-month periods each year, January to June and July to December.

At the start of each calendar year, and throughout the year as new activities are undertaken, data from each UC location is collected and validated by the Office of the President to identify activities to be included in OPA reporting: 1) uncompensated board memberships; 2) compensated board memberships, and; 3) other activities where compensation is anticipated to exceed \$2,500 in cash, stock or other compensation.

During the period of January 2022 – June 2022, 59 SMGs submitted a total of 125 anticipated activities. Of those activities, 93 activities were uncompensated board memberships, 22 activities were compensated board memberships, and eight activities were other activities with compensation exceeding \$2,500.

During the period of July 2022 – December 2022, 4 SMGs submitted a total of six anticipated activities. Of those activities, two activities were uncompensated board memberships, one activities were compensated board memberships, and three activities were other activities with compensation exceeding \$2,500.

The completed activities will be validated and reported as completed activities in the OPA Calendar Year 2022 report, to be released in July 2023.

- **2021 Compensated Activities:** The report includes a list of SMG members that completed board memberships compensated at any amount and any other activities compensated above \$2,500 during Calendar Year 2021. The report includes the name of the sponsoring organization, the non-profit/for profit status of the organization, the SMG member's role for each activity, the total hours used for each activity, and the compensation received for the activity.
- **Activities Undertaken for Calendar Year 2022:** The report includes a list of SMG members that reported anticipated activities to be completed during Calendar Year 2022. The report includes the name of the sponsoring organization, the non-profit/for profit status of the organization, the SMG member's role for each activity, the total hours anticipated for each activity, and the anticipated compensation, where applicable.

DATA COLLECTION, REVIEW, AND CERTIFICATION PROCESS

The OPA reports are produced from data collected by each UC location with appropriate direct manager and one level of approval as required for compensated activities. Multiple data quality reviews were conducted by the local entities and Office of the President (OP). The report consolidating the data for all UC locations systemwide is then submitted to the President of the University and the Board of Regents via a mailing in between meetings
