Entry Level Writing Requirement (ELWR) Fall 2017

The following report is forwarded in compliance with Section 66015.10 of the Education Code, which states:

- (a) The University of California is requested to annually notify the governing board of each high school of both of the following:
 - 1. The number of graduates who enrolled in the university in the previous year and the number of graduates who were required to take the entry level writing requirement.
 - 2. The comparable numbers of all California high school graduates who enrolled in the university.
- (b) The University of California is requested to provide an annual summary of the information specified in subdivision (a) to the Department of Finance and the Joint Legislative Budget Committee.

This document is the annual report responding to this legislative request.

Background

The University of California Entry Level Writing Requirement (ELWR) is a reading and writing proficiency requirement that is intended to assure that entering freshman students have the writing skills necessary to succeed in lower-division university-level courses. UC students must be able to understand and to respond adequately to written material typical of reading assignments in freshman courses, and this ability must be demonstrated in student writing that communicates effectively to university faculty.

The Academic Senate's University Committee on Preparatory Education (UCOPE) oversees the ELWR. This requirement may be satisfied by successfully completing a course or program of study in English composition during the first year of enrollment at UC. In addition, prior to enrollment at the University of California, a student may satisfy the ELWR by attaining a score approved by the Committee on one of the following examinations:

- 1. the University of California Analytical Writing Placement Exam,
- 2. the SAT Reasoning Test, Writing (last administered January 2016),
- 3. the ACT, Combined English/Writing (last administered June 2015),
- 4. the ACT, English Language Arts,
- 5. the Advanced Placement English Language and Composition Examination,
- 6. the Advanced Placement English Literature and Composition Examination,
- 7. the International Baccalaureate Higher or Standard Level English A: Literature Examination, or
- 8. the International Baccalaureate Higher or Standard Level English A: Language and Literature Examination.

An additional option for completing the writing requirement prior to enrolling at the university is the successful completion of a transferable college-level course in English composition of 3 semester or 4 quarter units.

Each May, the university offers its Analytical Writing Placement Examination (AWPE) to incoming freshmen who have not satisfied the ELWR by that date. The AWPE defines a basic level of proficiency in reading and writing for incoming students and sets a baseline of expectations that extends across all UC campuses. As the University Committee on Preparatory Education (UCOPE) observed at its April 2002 meeting, "it is very important to have a single University of California standard that clearly communicates to students, parents, teachers, and schools the academic reading and writing abilities expected of entering freshmen."

This report summarizes the outcomes of the ELWR for freshmen who entered the university for the fall 2017 term and provides fall 2016 data as a point of comparison (see Table 1 and Table 2).

Information to Schools

Each year, the university notifies California high school principals and county and district superintendents that comprehensive ELWR performance results are available on the AWPE Results website (www.ucop.edu/elwr/examdata/results/). These results may be useful to guide high school curriculum development that could improve the academic preparation of students.

The AWPE website (<u>www.ucop.edu/elwr/</u>) contains previously administered examinations, the scoring guide, and annotated sample student essays with reader comments exemplifying each scoring level. These resources are intended to help clarify the ELWR standard of competence.

Entry Level Writing Requirement Data on Entering Freshmen

The attached tables display ELWR data for fall 2016 and 2017 entering freshmen.

The University of California enrolled fewer California freshmen for fall 2017 (36,989) compared to fall 2016 (38,823), which is proportionately reflected in the number of entering freshmen that met the ELWR requirement, took and passed the AWPE, and met ELWR through means other than the AWPE compared to fall 2016. For fall 2017, the new SAT had not yet been approved as a method of satisfying the requirement, thus disrupting past trends for meeting the requirement "through other means" and impacting the number of students taking the AWPE. The new SAT was subsequently approved as a method of satisfying ELWR beginning with fall 2018 enrollees.

Of the 36,989 fall 2017 freshmen who entered the university, 26,807 (72.5 percent) met the ELWR prior to their enrollment. This rate is a slight decrease from the fall 2016 outcome of 75.6 percent (29,335) for newly enrolled freshmen. The percent of fall 2017 freshmen who fulfilled the ELWR includes students who successfully passed the AWPE (6,593, or 17.8 percent) as well as students who met the requirement through other means – 54.6 percent of entrants (20,214).

Slightly fewer enrolled students, proportionally and in number, took the AWPE in 2017; 39.3 percent took the 2017 exam (14,550 out of 36,989 enrollees) compared to 40.9 percent of the 2016 cohort (15,890 out of 38,823 enrollees). The AWPE pass rate was also lower for fall 2017 at 45.3 percent (6,593 out of 14,550 examinees) from 49.2 percent the previous year (7,814 out of 15,890 examinees). The proportion of students who met the

ELWR through other means prior to enrolling decreased from 55.4 percent (21,521) in 2016 to 54.5 percent (20,214) in 2017. The number of students required to meet the ELWR during their first year of enrollment at the university in 2017 increased in both absolute number and as a percent of the total; 10,182 (27.5) in 2017, compared to 9,488 (24.4 percent) in 2016.

The percentage of students who fulfilled the ELWR prior to enrolling differs by UC eligibility status. For fall 2017, the completion rate for regularly admitted enrollees was 72.7 percent or 26,705, while the completion rate for students admitted by exception was 38.1 percent (102 students). The ELWR completion rate for regularly admitted enrollees dropped from 75.8 percent in 2016 to 72.7 in 2017. The rate also dropped for students admitted by exception than the prior year's rate of 42.3 percent (or 118 students).

The percentage of all fall 2017 students who fulfilled the ELWR prior to enrolling varies by campus. In 2017, this ranged from a high of 90.4 percent at Los Angeles to 36.2 percent at Merced.

Passing the AWPE is one method of satisfying the ELWR prior to enrollment, and it is the primary method used when satisfactory scores on other tests are not met. A student who has not satisfied the ELWR prior to enrollment must do so as early as possible during the first year of attendance by successfully completing a specific course leading to satisfaction of the requirement. The following tables display information regarding the fulfillment of the ELWR for new entering freshmen from California high schools for fall 2017 and fall 2016.
