Insurance Market

With unknown domestic policy changes, resulting international retort and uncertainty in how the capital markets will respond, the commercial insurance market is poised for disruption in 2025 and beyond. Adding to potential policy and market volatility are the recent tragic LA wildfires which are projected to result in more than \$28 billion in insured losses and the continuing national trend of unexpected "nuclear" verdicts across multiple lines of insurance. In response, the University will continue to leverage the strength of its captive, Fiat Lux, to explore alternative risk financing opportunities and coverage options to best ensure cost efficiency and effective protection of the University.

The Risk Services team continues to work diligently with our systemwide colleagues to develop innovative risk prevention and mitigation solutions for FY 2025-26 that will further protect our campuses, medical centers, labs and all other UC affiliates as they strive to support the mission of the University.

Premium Rate Methodology

As a reminder, the University's insurance rates are determined by independent actuaries. The funding rates, established by individual lines of insurance, are calculated by using a location's discrete exposure and loss performance (based on a five-year claim history) with a blending of the University's total aggregate loss experience.

Insurance Programs:

Workers' Compensation (WC)

The University's Workers' Compensation program remains relatively consistent in terms of claims frequency over the last five years. However, the inventory of open claims and the rise of medical costs as a percentage of overall

claims expenses, continue to trend upwards over the same five-year period. To address these increases, in conjunction with our Third-Party Administrator, Sedgwick, we have implemented a program specifically focused on the review and reduction of our existing claim inventory. To address medical cost increases, we have initiated an RFP for Managed Care services with the goal of implementing a more cohesive and integrated program to produce more effective outcomes and cost efficiency.

While the funding for 2025-26 has increased by \$14MM, driven mostly by the increase in exposure projections, the funding rate remained flat at \$1.08 per \$100 of payroll.

As reported in prior funding letters the premium amount does not include the accounting of the continued closeout of our legacy workers' compensation program and transition from our traditional banking model to the University's captive insurance company, Fiat Lux. As a reminder, we are now in the final year of the seven-year closeout plan that in total, provides rate reductions of \$19.7 MM and deficit forgiveness of \$43.9 MM.

General Liability (GL)

Due to decreases in projected loss funding and excess insurance costs, the rate per FTE and total funding for 2025-2026 decreased year over year. The realized decrease was muted by the annual installment of the ten-year repayment plan for the Heaps matter which is included in the GL rate calculation. Absent the Heaps repayment plan, the program costs decreased by 7.8%.

Employment Practices Liability (EPL)

Primarily driven by adverse loss experience, increased litigation costs, and several unfavorable jury verdicts; the EPL program required a premium increase of \$4.6MM. Although requiring a premium increase, the overall rate per FTE decreased by 1.1% due to an increase in the exposure base for this program.

Sexual Misconduct Liability (SML)

As with prior years, this coverage is provided directly by our captive, Fiat Lux, which remains our only option given the lack of alternatives in the commercial insurance market. The SML program funding rate decreased by 10% over the prior year, equating to an overall premium decrease of \$1MM.

Auto (AL & APD)

Although the AL program experienced a small number of significant large losses, an improvement in overall programmatic losses and a decrease in program related expenses led to a 10% funding rate decrease.

Property

The University's continued focus on providing additional student housing and hospital construction, as well as recent acquisition activity, continues to add new buildings to our property schedule and increases our exposure in this area. Although our property insurance rate remains relatively flat compared to last year (1.3% increase), the 2025-2026 premium will increase by 8.6% over last year due to an increase in loss development and our total insurable values systemwide.

Cyber

Cyber premiums are decreasing by 2% compared to last year. This reduction is due largely to a reduction in program expenses, as we are still forecasting a 6% increase in ultimate losses.

Professional Liability (PL)

Nationwide the PL market is experiencing rising costs and increased severity of claims, with premiums increasing and insurers facing challenges, indicating the lead up to another potential "hard market". The University's PL program is not immune to these cost pressures and when coupled with our substantial increase in exposure (50%+ increase in bed capacity through acquisition) and the growing impact of California specific MICRA reform, leads to an overall premium increase of 36%.

While we understand the systemwide cost of insurance continues to increase, it is not without a commensurate increase in our commitment to continually evaluate our insurance structure and financing strategy to ensure we

provide the University maximum value in its insurance funding and protection of its human, intellectual, and property assets.

We also continue to focus on our ability to affect our own loss experience through claim prevention and mitigation of losses. Our loss prevention and mitigation efforts are most effective when developed from individual location loss analysis to identify and respond to those areas producing the greatest loss and potential liability. The Be Smart About Safety program continues to be an integral component of those loss prevention and mitigation efforts. Our Risk Services team is here to support you in your efforts and encourage all of you to ensure your location is taking full advantage of the funding provided by these risk management and safety programs.

As always, we look forward to continuing to partner with you and your teams and Fiat Lux to further reduce the University's cost of risk and create a safe environment for our students, faculty, staff, and the public.

Individual location reports will be sent to your campus and medical center risk manager and workers' compensation manager, separately.
