

### Redefine the Scope of Campus Safety



Campus safety is not just safety from violence. It is the cultivation of an inclusive community where basic needs and the roots of insecurity are addressed.

- Safety comes from adequate housing and nutrition.
- Safety comes from mental health access and support.
- Safety comes from promoting diversity and inclusion.
- Safety comes from integration with local communities.
- Safety comes from the transformation and restorative justice that reconciles histories of past harm.



#### Examine & Reallocate Police Resources


Large numbers of full-time armed police officers are not the answer to the safety needs of modern UC campuses.

- Reduce the number of armed sworn officers by at least 40%.
- Reduce munitions and use of militarized weapons.
- Dispatch non-sworn, unarmed staff and social workers to triage mental health crises.
- Better integrate CAPS psychiatrists and mental health professionals into safety infrastructure.





## Reject Mutual Aid to Local Police Departments



On-campus funds and facilities should not benefit (further) police injustice off-campus.

- Eliminate mutual aid agreements with municipal and state police agencies.
- Mutual aid should only be supplied between UC police departments and with clear transparency & accountability.
- UC must maintain jurisdiction and agency over campus safety needs.



#### Promote Transparency & Outcomes Tracking


Outcome tracking is a guiding principle of UC's public service and research missions. This academic thinking *must* influence campus safety transparency.

- Create a public systemwide dashboard tracking police actions disaggregated by demographic.
- Annual line-item disclosures of police department budgets and public input into budgeting process.
- Student "Know Your Rights" trainings, accessible independent grievance process, UCUES tracking.
- Clearly defined annual stop, arrest, and incident reduction targets to monitor progress over time.

#### **Empower Community-Led Accountability**



Students, faculty, staff, and community have shared governance over most university operations. Campus safety should follow these values.

- Elected campus independent oversight boards <u>must</u> <u>be</u> empowered with governance **authority** over budgeting, hiring, firing, and operational decisions.
- UCPD must institute a sworn officer hiring freeze while campuses reimagine the future of their safety.
- Students, faculty, and staff must have greater voice in future decision-making and police union contract negotiations.

#### Leverage UC's Platform for State & National Change

UC has the opportunity to be a leader in the reimagining of state and national policing. It should use its platform to champion an activist role.

- Endorse state police regulations:
  - AB 48 (Gonzalez): Inhumane Weapons Ban
  - AB 26 (Holden): Excessive Force Officer Intervention
  - SB 16 (Skinner): Transparency & Accountability
- Inform and champion emerging federal police regulations.

### Reimagining Campus Safety Requires Reinvestment

#### UC must invest in addressing the root causes of student insecurity to:

- 1. Improve Student Mental Health Support
- 2. Combat Student Homelessness
- 3. Address Undocumented Student Hunger
- 4. Support Foster Youth and System-Impacted Students
- 5. Scale Restorative Justice Initiatives



Improve Student Mental Health Support While improving, UC's student mental health infrastructure falls short of national best practices.

- Psychiatrist : Student Ratio
  - UC's ratio is 1 : 8,118
  - Recommended ratio is 1 : 6,500
- Counselor : Student Ratio
  - UC's ratio is 1 : 1,147
  - Recommended ratio is 1 : 1,035
- Proactive investments in mental health & wellness preempt longer-term crisis intervention needs.





# **Combat Student Homelessness**



4% of UC students report experiencing homelessness. We must bring that to 0%

- Housing insecurity is particularly felt by Black, American Indian, and international students.
- Homeless students report being overpoliced and are some of UC's most vulnerable students.
- Permanent investments in housing can address the root cause of homelessness.



# Address Undocumented Student Hunger

Undocumented students remain ineligible for SNAP benefits and face heightened food insecurity. UC can step in to help.

- Undocumented students have historically faced harm from law enforcement agencies.
- Creating a UC in-house food subsidy program for needy undocumented students can address underlying hunger issues.





#### Support System-Impacted & Foster Youth Students

System-impacted and foster youth have faced direct harm from campus and community carceral institutions. Directing support to these communities helps address past harm.

- Regents and state leaders have committed themselves to increasing retention support for foster youth and system-impacted students, yet many of these commitments remain unfunded.
- Investing in Guardian Scholars and Underground Scholars programs can support these vulnerable communities and scale their nationally recognized work.

#### Scale Restorative Justice Initiatives

Developing a systemwide-coordinated restorative justice program with campus-level solutions can reconcile past harm and support nation-leading research and program creation.

- Pilot restorative justice initiatives at campuses to reimagine justice within the academic community.
- Recruit, hire, and train restorative justice professionals who can make impacts in communities within and outside of UC.
- Provide grants and fellowships to undergraduate and graduate students conducting research on incarceration, policing, and justice.
